1. THIS RISK DISCLOSURE NOTICE FORMS PART OF THE CUSTOMER AGREEMENTS

- 1.1. This information provides you with a general description of the nature and risks associated with trading digital assets, it is important that you fully understand the risks involved before deciding to enter into a trading relationship with us. 2.2. There is no perfect way to prevent technical glitches, human error.

3. TRADING CAN BE AFFECTED BY GAPPING

- 3.1. Market volatility can cause prices to move from one level to another without actually passing through the level in between. Gapping (or slippage) usually occurs during periods of high market volatility. As a result, trading won't be carried out to avoid losses.
- 3.2. Other cryptocurrencies have been comparatively more stable, but new technologies are often likely to attract speculative interest

4. THE BOTTOM LINE RISK

4.1. There is no such thing as a risk-free stock or business. Although every stock faces these universal risks and additional risks specific to their business, the rewards of investing can still far outweigh them. As an investor, the best thing you can do is to know the risks before you buy in, and perhaps keep a bottle of whiskey and a stress ball nearby during periods of market turmoil.
